IN 2010, CEP CONDUCTED A STUDY THAT RESULTED IN THE REPORT, "WORKING WITH GRANTEEES: THE KEYS TO SUCCESS AND THE FIVE PROGRAM OFFICERS WHO EXEMPLIFY THEM." CEP ALSO RELEASED ONE CASE STUDY ON THREE FOUNDATIONS' APPROACHES UNDERSTANDING THE FIELDS IN WHICH THEY FUND.
