IN 2008, CEP CONDUCTED A STUDY THAT RESULTED IN THE REPORT, "More than Money: Making a Difference with Assistance Beyond the Grant." CEP ALSO RELEASED TWO CASE STUDIES ON THE DAVID AND LUCILE PACKARD FOUNDATION AND THE WALLACE FOUNDATION. CEP'S RESEARCH TEAM FOCUSED A GREAT DEAL OF ITS WORK ON FOUNDATION STRATEGY, FIELDING A LARGE-SCALE SURVEY TO FOUNDATION CEOS AND PROGRAM OFFICERS AND CONDUCTING ANALYSIS ON FINDINGS.
